During that period there have been a substantial number of changes in geotechnical engineering, especially in the applications of foundation engineering. As the world population increases, more land is needed and many soil deposits previously deemed unsuitable for residential housing or other construction projects are now being used. Such areas include problematic soil regions, mining subsidence areas, and sanitary landfills. To overcome the problems associated with these natural or man-made soil deposits, new and improved methods of analysis, design, and implementation are needed in foundation construction. As society develops and living standards rise, tall buildings, transportation facilities, and industrial complexes are increasingly being built. Because of the heavy design loads and the complicated environments, the traditional design concepts, construction materials, methods, and equipment also need improvement. Further, recent energy and material shortages have caused additional burdens on the engineering profession and brought about the need to seek alternative or cost-saving methods for foundation design and construction. While enormous progress has been made towards sustainability, the scope and opportunities for improvements are significant. To further the effort for

sustainable development, a conference on Sustainable Construction Materials and Technologies was held at Coventry University, Coventry, U.K., from June 11th - 13th, 2007, to highlight case studies and research on new and innovative ways of achieving sustainability of construction materials and technologies. This book presents selected, important contributions made at the conference. Over 190 papers from over 45 countries were accepted for presentation at the conference, of which approximately 100 selected papers are published in this book. The rest of the papers are published in two supplementary books. Topics covered in this book include: sustainable alternatives to natural sand, stone, and Portland cement in concrete; sustainable use of recyclable resources such as fly ash, ground municipal waste slag, pozzolan, rice-husk ash, silica fume, gypsum plasterboard (drywall), and lime in construction; sustainable mortar, concrete, bricks, blocks, and backfill; the economics and environmental impact of sustainable materials and structures; use of construction and demolition wastes, and organic materials (straw bale, hemp, etc.) in construction; sustainable use of soil, timber, and wood products; and related sustainable construction and rehabilitation technologies.

Although it is known that impact compaction tests are not appropriate for granular soils, these tests continue to be widely used. Excessive settlements frequently occur in granular soils where specified field compaction is based on Standard Proctor (ASTM D 698; AASHTO T 99) maximum dry unit weights. A laboratory test program evaluated alternative test methods for granular soil

compaction control and showed that a Vibrating Hammer method (similar to British Standard BS 1377:1975, Test 14) has great promise for laboratory compaction of these soils.

An overview of recent developments in constitutive modelling, numerical implementation issues, and coupled and dynamic analysis. There is a special section dedicated to the numerical modelling of ground improvement techniques, with applications of numerical methods for solving practical boundary value problems, such as deep excavations, tunnels, shallow and deep foundations, embankments and slopes.
