This manual provides guidance for organizing and facilitating training of trainers in gender-sensitive rural advisory services design and delivery. It has been developed as part of the FAO project "Capacity Development Support to Rural Women on the Socio-economic and Gender Aspects of Sustainable Rural Development", which was implemented in Turkey and Azerbaijan, in 2014-16.
